Entrepreneurship has become popular since it was taught at Harvard Business School in 1947 (Jung & Lee, 2020) as one of the personal capital that exists in a human being. The potential for this personal capital can be explored, triggered, and developed so that they can become strong and competitive individuals (Titien Agustina, Jatmika, Sampurnawati, & Djuarni, 2023). There are 2 (two) components related to skills in supporting the success of an entrepreneur, which are determined by his mindset, namely personal skills and social skills. This research more specifically discusses skills or personal capital, the potential of which already exists within every human being (Titien Agustina, 2019a). The potential to become a winner or succeed as a great human being is ingrained from the beginning of a person's birth. This provision has been given by God, only to make it appear requires efforts to explore, hone, and develop further entrepreneurship.

Success is everyone's dream. Both in work, education, family, life, and in everything you want or plan. Success is an achievement where what is desired, planned implemented can be achieved well,

If you don't succeed, you can interpret or manage your failure well to get back up and be enthusiastic about achieving the desired success with a new strategy.

The entrepreneurial mindset is the frame of mind of someone who is entrepreneurial-oriented, prefers to live with uncertainty rather than avoid it, sees things more simply than other people who see them complexly, is willing to learn something, and dares to be a risk-taker (McGrath & McMillan, 2000). An entrepreneurial mindset can also be interpreted as a personal skill that a person has from within himself (Krueger & Sussan, 2017) which is demonstrated through thinking (self-confidence), independent attitudes and behavior, being open to change or new things, being creative, innovative, and attitudes like a genuine entrepreneur (Neneh, 2012).

Therefore, an entrepreneurial mindset is an important factor (Lahindah & Manurung, 2017) which is the capital needed by anyone engaged in any field of work. Everyone can run and follow the capital within them through this entrepreneurial mindset. Because no one is the same, but everyone has the opportunity to choose and control (lead) their choices with all the risks that they "dare" to accept and face optimally like an entrepreneur. Literature Review

Entrepreneurship is a field of study that continues to develop and become more established so that it can be recognized as a scientific field. The beginning of the growth of entrepreneurship was when inventors and technocrats in ancient times started by changing the mindset of thinking from existing habits in society. Among them are early figures who started developing personal capital within themselves as a potential as well as skills in using thought patterns into attitudes and behavior patterns (Neneh, 2012), such as an entrepreneur, or entrepreneurial mindset which supports a person's success in a competitive era. This. Among them, some became victims because of their "courage" in expressing a different opinion (risk-taking). Choosing a different attitude based on logical and basic strength in synergy with controlled emotional sharpness. The decision to disagree with someone else's opinion or understanding shows that he is a person who does not follow suit. But I prefer to be a different person, then dare to create a difference But quite a few are also trying to use a different attitude to pioneer something new

Dare to be different in thought patterns and attitudes has been demonstrated by previous pioneers of science. Among them is the Greek philosopher, Aristotle, who stated that the shape of the earth was round (around 330 BC), followed by Pythagoras (around 500 years BC). Next included Copernicus (1473-1543) then Galeleo Galilei (1564-1642). Because the entrepreneurial mindset that exists within the person concerned, then gives birth to the ability to create, be different in opinion, and behave. useful for changing the world today. The entrepreneurial mindset underlies the birth of new works because there is an entrepreneurial spirit that grows and develops within them.

These are all traits or characteristics of an entrepreneur that are deeply embedded in a person and become personal capital. So that when the person concerned is faced with various things or events, people with personal characteristics that are owned as capital in themselves, will become capital that directs their thoughts, attitudes, and behavior to become a person (human) who is different from the majority of people around them. So, this personal capital becomes a marker that differentiates the work or achievements that can be printed in their field.

Method

This research uses a qualitative approach and descriptive methods. Qualitative research is research that uses a natural setting, to interpret phenomena that occur, and is carried out involving various existing methods. In the entrepreneurial adversity question, measure a person's intelligence to be able to survive all the problems or challenges that come their way (Titien Agustina, Gerhana, et al., 2020) and (Hakim et al., 2023).

An entrepreneurial mindset will give birth to entrepreneurial behavior (Davidsson, 1989); (Gartner, 1993); (Lumpkin, G. T. dan Dess, 1996); (Krueger & Sussan, 2017); (Wiklund, 1999); (Mathisen & Arnulf, 2012). This is considered a manifestation of entrepreneurial behavior (McGrath & McMillan, 2000) suggesting that if a person knows that he or she has fully implemented an entrepreneurial mindset, when that person begins to act and think like the habits of an entrepreneur, the results will be different (Lumpkin, G. T. dan Dess, 1996). This will be stimulated and in turn there will be continuous growth within him (Wiklund, 1999).

Closing

An entrepreneurial mindset consists of personal and social skills. In practice, knowledge, awareness, understanding, and development of personal characteristic capital that exists within every human being (human resources) need to explore personal capital from the sharpness of an entrepreneurial mindset. This is a framework that needs to be considered to build and support the creation of strong and great human resources in this competitive era.
